



# Humans of the Registry

From the Registered Humans website: We hope you find these snapshots of registrants' lives insightful and even inspirational. All of our contributors have been convicted of some form of a registerable sexual offense. These offenses can range from youthful sexual activity to very

serious convictions. Our storytellers have accepted responsibility for any past harm. They wish to reflect not only on the impact of being on the registry, but on what brings them happiness now: their accomplishments as well as their hopes and dreams. We've chosen to focus on each individual as they are now; not as who they were in the past or what they were punished for. They all have unique stories to share with you as humans who've been registered. We hope you will share their stories with others who might benefit from their journey and vision for the future.

## Share Your Story

If you are on the registry and have been offense free for a year or more, we hope you will participate in this project. We will screen and post the stories that seem to most advance the goals of the project.

This 700 word "snapshot" of your life should capture the best parts of your life, the contribution you make to society and, if appropriate, your family life. You can briefly mention your conviction, *but the focus is on your life NOW*, and the lives of people you care about. *The goal is to provide encouragement to other registrants and break the stereotypes that hold registrants down.*

The published story *must* include either your full name or your first name and middle initial, and an interesting photo or two of you. We will ask for additional information which we will keep in confidence. Here are some questions to ponder as you write your piece. You may select one, several, or none of them for your story. They are just a guide to get you started.

- What are the things in your life today that bring you the most happiness?
- What is the best thing you are doing with your life right now?
- Are you in a committed relationship? Have children at home?
- Are you involved in your community in a positive way?
- Have you received any awards for community or military service?
- Are you employed?
- If you wish, share any feelings or thoughts you might have about your conviction.
- What about being on the registry has caused you or your family and friends the most harm?
- What is the best and worst moment you have had since being on the registry?
- What are you most proud of accomplishing despite being on the registry?
- Is there something else about you that other people might find interesting (e.g. a special event in your life, special accomplishment, interesting background, etc.)

Contributors must READ AND SIGN our agreement before they submit a story. If you have not done so, please read and sign now. ## Agreement

In consideration for being permitted to participate in Registered Humans, a project of National Association for Rational Sexual Offense Laws (“NARSOL”), the undersigned, for himself or herself and such participating household members (individually and collectively, the “Participant”), hereby releases and agrees to hold harmless NARSOL and its directors, agents, employees, volunteers, sponsors, independent contractors, officers, or other affiliated entities, and all other persons or entities acting on its behalf (together, the “Released Parties”), together with their successors and assigns, from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the Participant’s past, current or future participation in Registered Humans. The Participant voluntarily desires to participate in Registered Humans and any travel required. The Participant understands that publication of stories and photos may create a risk to the Participant. The Participant acknowledges these hazards and voluntarily assumes any and all the risks of loss, damage or injury associated with such participation.

1. Waiver and Release: The Participant understands and acknowledges that this Release discharges the Released Parties from any liability or claim that the Participant may have against the Released Parties with respect to bodily injury, personal injury, illness, death, property damage or any other damage that may result from the Participant’s participation in the Registered Humans project.
2. Insurance: The Participant understands that the Released Parties do not assume any responsibility for or obligation to provide the Participant with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. The Participant expressly waives any such claim for compensation or liability on the part of the Released Parties beyond what may be offered freely by the Released Parties in the event of injury or medical expenses incurred by the Participant.
3. Medical Treatment: The Participant hereby releases and forever discharges the Released Parties from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services, including counseling, therapy or any mental health associated treatment, rendered in connection with any event during the Participant’s participation in the Registered Humans project.
4. Photo and Video Disclaimer: NARSOL reserves the right to use any photograph/video received or taken as a part of the Registered Humans project without the permission of those included within the photograph/video. NARSOL may use the photograph/video in publications or other media material produced, used or contracted by NARSOL including but not limited to: brochures, invitations, books, newspapers, magazines, television, websites, etc. To ensure the privacy of individuals and children, images will not be identified using full names or personal identifying information without written approval from the photographed subject, parent or legal guardian.
5. Other: The Participant agrees that this Agreement is intended to be as broad and inclusive a release of liability as permitted by law, and that if any portion thereof is held invalid, it is agreed that the remaining balance of this Release shall continue in full legal force and effect. The Participant agrees that binding arbitration before a single arbitrator pursuant to the Rules of the American Arbitration Association shall be the exclusive means of resolving all disputes arising out of or relating to this Agreement or participation in the Registered Humans project. The Participant understands that they may revoke this agreement solely with respect to future participation by sending written notice of revocation to NARSOL, PO BOX 36123, ALBUQUERQUE, NM 87176 (which shall be effective not less than 10 days after receipt). NARSOL will remove any posted information from its website and discontinue any future printed media that contains the Participants’ information and/or image(s). Participant agrees not to pursue or participate further in the Registered Humans project after such revocation.

By signing below, the Participant expresses understanding and intent to willingly and voluntarily surrender and waive any rights to sue or exercise any legal right to seek any actual, direct, indirect, incidental, special, exemplary, punitive or consequential damages from any of the Released Parties, either under this Agreement or under any theory of contract, tort, wrongful death, negligence, strict liability, statutory liability, warranty or otherwise.

THE PARTICIPANT HAS READ AND VOLUNTARILY SIGNS THIS AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.
